# PREPARING FOR OUR FUTURE

We have enjoyed celebrating our 100th year at Valley Senior Living! It has been a year of great support locally while we celebrated. I've heard many stories from people reminiscing about visiting their families at Valley over the years and about the wonderful care they received.

We've had great support at the state level. I would like to thank our North Dakota Legislators for their support of the long term care profession during the 2025 session. Our nursing homes are some of the best staffed in the country due to the Legislature's constant support each biennium, largely supported by the booming oil and gas industry in our state. As a native of our state, I'm proud of how we take care of our most vulnerable citizens when they need this level of care.

At the federal level, we have had a number of challenges and uncertainty, but the long term care profession has fared well overall. First, the Medicaid cuts over the next ten years does not affect program funding for long term care. Second, we were happy to see Congress put a 10 year delay on the implementation of federal minimum staffing standards. While most facilities in North Dakota meet the minimum overall staffing levels, the 24/7 RN requirement would have been devastating to smaller facilities in rural communities in North Dakota and across the country.

There is more to accomplish at the state and federal level. Through Congressional intervention, our profession is hopeful to see change in the punitive way the Centers for Medicare and Medicaid Services (CMS) administers the system that oversees nursing home care. Within our state, we will be working to change the system for funding the property component for new nursing homes. Without significant changes, no new nursing home will be built in our state unless it is funded by donations.

In July 2024, we purchased six acres of land next to Sertoma Park across the coulee from Altru Hospital. We continue to be in discussions with Altru about acquiring the additional adjacent land for our campus of the future.

This year we focused on intermediate financial goals to prepare us for a new campus:

- We continue to fund capital projects throughout the organization while paying down on our long-term debt.
- We added \$5.3 million of assets to the parent organization of Valley Senior Living to provide maximum flexibility for investment and use of those funds.
- Our annual audit now includes the Foundation to project the full financial health of the organization.

I would like to thank all staff at Valley Senior Living for making a difference in the lives of residents each day. We take great pride in the care we provide and we are proud to extend our streak of not having a single shift of nurse or CNA staffing agency (travel) since 2003! Thank you to the entire leadership team and the Executive Committee of the Board for your dedication to residents and staff. We look forward to serving Grand Forks and the surrounding region for many years to come!

# FINANCIAL **OVERVIEW**

#### 2024-2025 Fiscal Year Highlights

As of June 30, 2025, Valley Senior Living and its subsidiaries including Valley Homes and Services, 4000 Valley Square, and Valley Senior Living Foundation, issued consolidated financial statements reflecting continued financial stability. The organization reported net assets totaling \$37.5 million, supported by \$17.1 million in cash and short-term investments. Additionally, \$5.0 million was allocated to funded depreciation, and \$5.6 million was held in restricted reserves by the bond trustee. These resources translate to approximately 127 days cash on hand when considering operating cash and funded depreciation, and 160 days when including the restricted bond reserves. During the fiscal year, \$3.2 million was transferred from 4000 Valley Square to the parent corporation, reinforcing centralized financial management. The Valley Senior Living Foundation held \$4.0 million in board-designated, donor-designated, and endowed funds, all invested to support the organization's future needs and long-term mission.

For the year ending June 30, 2025, the organization experienced an increase in net assets of \$3.6 million which equates to a 5.8% margin for the year. This margin includes accrued revenue of \$2.0 million from the Employee Retention Credit (ERC) and \$379,636 in ND Nursing Facility Incentive Program Payments (NFIP), with both explained below. The margin excluding ERC was 2.5%.

#### **Employee Retention Credit**

The organization filed for \$11.4 million in ERC credits in 2023 relating to the first three quarters of 2021. The ERC grant revenue and receivable were recorded in the year filed (2023), and the accrued interest was recorded as a contribution. During the fiscal year \$2,031,091 in additional ERC revenue was recorded. The first quarter ERC payment with interest was received in June 2025, totaling \$4.8 million. The remaining two ERC quarters are reflected as a receivable on the Consolidated Balance Sheet totaling \$9.8 million.

#### **ND Nursing Facility Incentive Payments**

North Dakota Health and Human Services established a quality incentive payment program for nursing homes in 2024. We received the second year of NFIP payments this year. Facilities are awarded points for performance in various categories. Woodside Village was a Tier 1 facility and received \$155,285 and Valley Senior Living on Columbia qualified for Tier 2, receiving \$224,351 for FY 2025. We anticipate both nursing homes receive similar NFIP payments again next June.

#### **Land Purchase**

In July 2024, Valley Homes and Services purchased six acres of land for \$1.84 million for future development. The Valley Senior Living Foundation contributed \$662,387 of board designated funds towards this purchase.

#### Other Operational Highlights: Occupancy and Staffing, and Capital Improvements

Consolidated occupancy for the year was 95% compared to 96% consolidated occupancy in the prior year. See the following chart for the communities' occupancy rates. All communities exceeded 95%, except for Tufte Manor, which dropped to 86% this past fiscal year.


Total salary and benefit expenses increased 5% compared to 6% the prior year. Staffing levels were stable throughout the year, with small periods of more open positions. Overtime and incentive pay to fill shifts remained low for the third year in a row. It remains a high priority for Valley Senior Living to continue to recruit and retain quality staff.

#### Outlook for 2025-2026

The 2025-2026 budget is projecting a small profit margin of .6% but an improved cash position due to anticipated receipt of remaining ERC payments. The organization is currently evaluating investment options for cash reserves. The budget assumes consolidated occupancy at 94.8%, a .2% increase in revenues and a 6.8% increase in expenses. Woodside Village's occupancy is budgeted at a lower level due to resident room remodeling. Tufte Manor has seen a decline in occupancy this past fiscal year and is budgeted at 86% for 2025-2026. Capital budget for the next fiscal year is approximately \$5.0 million and includes the Woodside Village project and public area remodeling at Tufte Manor. For both nursing homes the 2025-2026 fiscal year is a rebasing year for rate setting; expenses during that period will set rates in 2027 and serve as the base for inflated rates the subsequent three years. The organization is moving forward with strategic plan initiatives and planning for the future long term care needs of our community.




